Spring is here at last, and most of us will have had the reassurance of at least the first vaccination. We had ours done in a very slick operation at Peterborough Showground, but from what I hear all vaccination centres have been very efficiently run with cheerful and friendly staff and volunteers. By the time you read this, most people over the age of 50 will have been vaccinated, and that is a magnificent achievement.

It is too early to rush back to normal life, but we can start thinking about meeting friends and family again. Postponed holidays are beginning to look possible and eating out may become a reality again. After we have all been vaccinated, and assuming the Government's timetable is not disrupted by some unforeseen event, U3A activities can resume.

Three Committee members are standing down and it is time for some of our newer members to take a turn at helping to run Bourne U3A. The Committee only meets once a month and there is no better way of finding out what goes on or meeting new people. There will be lots of help and support for anybody new to Committee work and playing a part in our recovery from the pandemic will be very rewarding.

RAILWAY GROUP

For our fourth speaker meeting via zoom Tom Ingall of the Great Central Railway preservation trust gave 29 of us a fascination insight into the workings of the operation. He gave us a potted history of the society since it's formation in 1962, which immediately followed the BR closure of the line by Dr R. Beeching. The reason for the closure was deemed that the line duplicated the East and West Coast Main Lines. As part of the closure process, bridges were removed and embankments were destroyed. This meant that the old GCR had two halves, separated by the bridge which traversed another main line – this meant that there had to be TWO heritage railway organisations. These organisations currently operate their own heritage railways – and very successfully. However, the ideal is for the bridges to be reinstated and one through route is formed again.

The main thrust of Tom's talk was about the work being done to join the two halves together again. The main bridge has been made and put in place but much work needs to be done to replace essential elements of the bridge and surrounding embankments and structures. There is no date for completion of the work as it is totally dependent upon the rate of funding coming in. For our part, we donated a sum towards the cause which will probably buy a handful of nuts for erecting the bridge side barriers!! But as Tesco says "E"

As an interesting side-issue to the talk was a question asked by an audience member: "Could the GCR, once completed, be a main link, once again, between Marylebone and Manchester?" If so, why not do this instead of HS2? Answer: "not known".

A very interesting and well presented talk. Without Zoom, we would be lost souls.
